Part A: Pupil premium strategy plan

Statement of intent

Our intention is that all pupils, irrespective of their background or the challenges they face, make good progress and achieve high attainment across all subject areas. The focus of our pupil premium strategy is to support disadvantaged pupils to achieve that goal, including progress for those who are already high attainers.

High-quality teaching is at the heart of our approach, with a focus on areas in which disadvantaged pupils require the most support. This is proven to have the greatest impact on closing the disadvantage attainment gap and at the same time will benefit the non-disadvantaged pupils in our school. Implicit in the intended outcomes detailed below, is the intention that non-disadvantaged pupils' attainment will be sustained and improved alongside progress for their disadvantaged peers.

Our strategy also reflects wider school plans for education recovery, providing targeted support for pupils whose education has been worst affected, including non-disadvantaged pupils.

Our approach will be responsive to common challenges and individual needs, based on ongoing assessment, not assumptions about the impact of disadvantage. The approaches we have adopted complement each other to help pupils excel. To ensure they are effective we will:

- ensure disadvantaged pupils are challenged in the work that they're set
- act early to intervene at the point need is identified
- adopt a whole school approach in which all staff take responsibility for disadvantaged pupils' outcomes and raise expectations of what they can achieve

Challenges

Note: Due to the size of our school and the small number of disadvantaged pupils, there is no clear trend in terms of the challenges to achievement that these pupils face.

However, typical issues include:

Challenge number	Detail of challenge
1	Communication and language difficulties – observations and assessments have identified some gaps relating to reading comprehension and vocabulary amongst disadvantaged children
2	Gaps in learning following lockdown – national data has shown that school closures have resulted in gaps in learning. Although teaching has now returned to normal, there may be ongoing impact in terms of pupil attainment.
3	Lack of cultural enrichment – due to the mono-cultural nature of rural Cumbria, it is particularly important that our pupils have access to opportunities for cultural enrichment, especially those that are disadvantaged.
4	Social and emotional issues – to address the wellbeing of children (again, including the impact of lockdowns)

Intended outcomes

This explains the outcomes we are aiming for **by the end of our current strategy plan**, and how we will measure whether they have been achieved.

Part B: Review of outcomes in the previous academic year

Pupil premium strategy outcomes

This details the impact that our pupil premium activity had on pupils in the 2021 to 2022 academic year.

Aim 1 - Improved reading attainment among disadvantaged pupils.

Aim 2 - Improved maths attainment for disadvantaged pupils at the end of KS2

Outcome - there was one Pupil Premium child in Year 6 in 2022 - this child was at the expected standard in writing, grammar (SS 104) and maths (SS 108), and at greater depth in reading (SS 114). This child made positive progress in all areas (reading +8.5, writing +1.4, maths +3.8).

Aim 3 - To achieve and sustain improved wellbeing for all pupils in our school, particularly our disadvantaged pupils.

Outcome - in 21/22 we provided a wide range of enrichment activities to promote engagement and well-being. Some of these were incorporated into lessons, such as specialist instrumental music teaching and PE enrichment (climbing, horse riding, fell walking). We extended our after school club provision to include activities to appeal to children's interests, including art, gardening, theatre skills and sports clubs. We also provided a range of trips and residential, established a weekly nurture group to address social and emotional needs and worked closely with local secondary schools and supported Year 6 through the transition process (Year 6 booster club, trips to meet other Y6 children, visitors from secondary schools).

We write to parents of PP children each autumn term to make clear that their children qualify for PP and that this money can be used to support their access to the above opportunities - as a result, PP children regularly attend clubs, trips and residential.

Our pupil survey (July 22) indicated that 100% of children feel safe and cared for, believe the school helps them to solve friendship problems, encourages them to be kind and caring and teaches them how to behave.

Similarly our parent survey (July 22) indicated that 100% of parents feel that their children are happy in school, that staff understand their children's need and are quick to address any concerns parents may have and that their children have opportunities to take part in a wide range of activities inside and outside of school.

Aim 4 - To maintain high levels of attendance for all pupils, particularly our disadvantaged pupils.

Attendance improved well between 2018/19 and 2019/20 amongst children eligible for Pupil Premium (from 96.5% to 98.5%) and, in 2020-21, attendance of PP children was 97.8%. However, the disruption caused by Covid-19 impacted on attendance figures in 21/22 - whole school figures fell to 94.3% and for PP children, this fell to 92.44% (however, this was impacted by additional health factors).
